"OFFICE ORDER"

The Government of India has introduced a scheme for formation and promotion of Farmer Producer Organizations (FPOs) for providing end to end need based handholding & financial support to ensure better income realization to its members through aggregation and, if feasible, value addition. The Department has also set a target to organize at least one FPO in every Administrative Block of the State.

The scheme of FPOs has great potential and scope for socio-economic upliftment and betterment of farmers of the State. But ^{due} to the dearth of officers at Directorate level, the targets of the scheme fixed by the Department could not be achieved. Keeping in view the above scenario and for organizing, establishing or making these FPOs self sustainable and viable in times to come, a need to depute an experienced officer exclusively for the purpose at the Directorate level is felt.

Therefore, Sh. Kuldeep Kumar, Assistant Registrar Cooperative Societies Una is hereby deputed in Directorate of Cooperation to form, promote and monitor FPOs with immediate effect.

During the deployment period, the above named officer shall explore the possibilities of forming FPOs; prepare proposals for formation of FPOs in the State; act as a single window for Cooperative interested in forming FPOs; coordinate with various financing Institutions for making the necessary funds available for FPOs and shall be responsible for early action in every proposal of FPOs and expeditious disposal thereof.

In addition to above, it is also ordered that the additional charge of the post of Assistant Registrar Cooperative Societies, Una shall be held by Sh. Pratyush Chauhan, Assistant Registrar Cooperative Societies, Hamirpur in addition to his own duties.


