Whereas; the society namely EARTHLINGS HABITAT SOCIETY, Christ Church Annexe, The Ridge, Shimla, H.P. 171001 was registered under the provisions of the Himachal Pradesh Societies Registration Act, 2006 (Act No. 25 of 2006) vide registration No. 649/2013 dated 27-02-2013;

whereas, as per the contents of Resolution No. 1 of the proceedings of the Special General Body Meeting of the society held on dated 25-07-2021, it has failed to undertake activities/ functioning of the society as per its Memorandum of Association and Bye laws and the members of the society have shown their inability to devote time for its further functioning and unanimously have resolved to dissolve/windup/close the society;

whereas, the President and the General Secretary of the society vide letter No. EHS/RC/2021-03 dated 31-07-2021 have requested to dissolve and close the Society immediately in view of the above narrated circumstances;

whereas, the assets & liabilities of the society have been made nil as per the audited balance sheet as on dated 20-08-2021 submitted by the society vide its letter No. EHS/RC/2021-02 dated 31-08-2021 audited by Chartered Accountants i.e. Rakesh R.S.Garg & Company and duly signed by the President of the aforesaid society;

whereas; the audited balance sheet of the society depicts no assets and liabilities on dated 20-08-2021 and process for dissolution as required under section 44 of the Himachal Pradesh Societies Registration Act, 2006 (Act No. 25 of 2006) stand completed thus the society needs to be dissolved/cancelled as resolved by the members of the society in the Special General Body Meeting referred above and requested by the office bearers of the society vide letter dated 31-07-2021.

Therefore, I Rajesh Sharma, IAS Registrar of Societies, Himachal Pradesh do hereby cancel the registration of the society namely EARTHLINGS HABITAT SOCIETY, Christ Church Annexe, The Ridge Shimla, H.P. 171001 registration vide No. 649/2013 dated 27-02-2013 on this 12<sup>th</sup> day of November, Two Thousand Twenty One (12-11-2021).
