"Order"

Whereas, term of the Board of Directors of the H.P. State Milk Producers Federation Ltd; Totu, Shimla is going to expire of 15.8.2023;

Whereas, Chairman of H.P State Milk Producers federation Ltd; tender his resignation to the Managing Director of Milkfed on 27.06.2023;

Whereas, the Managing Committee of H.P. Milkfed had drawn up the elections programme and submitted the same to the undersigned vide letter No. HMF/HQ-II/Estt.-38/84-2523, dated 17.05.2023 for approval;

Whereas, undersigned approved the election programme submitted by H.P. Milkfed on 07.06.2023 vide office order No. 6-24/2023-Coop.(T&M)- (Milkfed) under the provisions of H.P. Cooperative Societies Rules, 1971;

Whereas, stakeholders have submitted the request to Deputy Registrar ( Central Division) Cooperative Societies, Mandi, Distt. Mandi and District Shimla stating that due to blockage of road and bad weather conditions many stakeholders are unable to participate in the election of the BOD of Milkfed and also requested to re-schedule /cancel the election process, keeping in view monsoon season.

Whereas, heavy rainfall in several parts of the State have caused damage to the road and bridges which has badly affected the rural connectivity. Most of the milk cooperative societies are working in these rural areas of the State are members of the federation. In such critical circumstances, representative of members cooperative societies of the federation are not in position to ensure their active participation in the election process of the federation. In current prevailing situation, it may not be feasible for returning officer, registration officer and other officials deployed to convene the election process of the federation smoothly due to poor road connectivity specially in far flung rural areas of the State;

In view of the facts narrated herein above, and taking cognizance of the fact that the transportation system in rural areas has been severely hit due to heavy rainfall/ flash floods all over the state, it is thought proper and expedient that the present election process in the above referred federation is required to be cancelled so that representative of every milk cooperative societies can have a opportunity to participate in the election of the federation.

Now therefore, I Rajesh Sharma, I.A.S Registrar Cooperative Societies, Himachal Pradesh, on the approval of the State Government do hereby cancel the election programme of the Board of Directors of H.P Milkfed approved from 09.06.2023 to 16.08.2023 until the road condition will improve so that members in the rural areas can participate in election process without any hindrance. Further schedule of elections will be issued after the monsoon season is over and for that member societies shall be dully intimated.
