**"DIRECTIVE"**


Whereas, a request has been received from the Secretary Kailash District Co-op Marketing & Consumer Federation Ltd. Shimla that TA/DA rates allowed to the Board of Directors of the federation are very meagre and inadequate in the present scenario since the rates were approved eleven years back.

Whereas, the request has been examined in detail vis-a vis the financial position of said federation and it is observed that the federation is earning profit and the financial position is satisfactory.

Presently, the federation is paying Rs. 300/- as sitting fee and Rs. 200/- as D.A for the Chairman and members of the BOD and @Rs. 5/- Per K.M for performing journey by own car as allowed vide Directive of even number dated 23-05-2009.

And whereas, the request of the federation in view of the financial position the sitting allowance, HRA for Chairman and Daily Allowance for the Chairman and members of the BOD is hereby fixed/allowed as under with immediate effect:-
