ORDER

In pursuance of the power vested in me under Rule 56 (1) of the H.P. Co-operative Societies Rules, 1971, following amendment is approved in the Rules Relating to the Terms of Employment and Working Conditions of the Employees of Primary Agriculture Co-operative Societies, (PACS) 2001:-

**1. Short Title and commencement:** (1) These Rules shall be called the Rules relating to the terms of Employment and Working Conditions of the Employees of PACS, (Amendment) Rules, 2021.

(2) These shall come into force with immediate effect.

**2. Amendment of Rules 14 – (EMPLOYEES WELFARE FUND):-**

(1) For existing clause (3) of above Rule 14, the following shall be substituted, namely:-

Save as provided above, for first ten years of continuous service, a fixed retirement assistance of rupees fifty thousand shall be paid, and, thereafter, for every successive completed year of service or part thereof excess of six months, the retirement assistance shall be at the rate of 15 days pay for every completed year of service or rupees ten thousand whichever is more subject to a maximum retirement assistance of rupees Seven lac out of Employees Welfare Fund so maintained at the society level.

The rest of the contents of order No. 5-508/98 Coop. (C&M)-IV dated 24<sup>th</sup> June, 2016 shall remain the same.
